The Business of the November 2021 EGM

- > Votes will be taken on three ordinary resolutions which require a simple majority of those voting.
- The resolutions to be voted on are:
 - To make changes to the LINX Memorandum of Understanding (MoU) and an MoU referenced document, to change LINX subdomain mailing lists, by making the following amendments:
 - i. change all references in the MoU to LINX operated mailing lists so that they refer to the subdomain @lists.linx.net instead of the main domain @linx.net.
 - ii. make the same changes throughout the MoU referenced document, 'LAN announcements reference document'.
 - 1. To approve the remuneration of elected directors for 2022.
 - 2. To approve the LINX services and fees for 2022.



Resolution 1:

THAT Clause 4.5 of the LINX Memorandum of Understanding be replaced by

- **4.5** You will make sure that at least one member of your staff is subscribed to the following mailing lists:
 - 4.5.1 The LAN announcement(s) mailing lists, specific to your peering service or services, where the mailing list details can be found in the 'LAN announcements reference document';
 - 4.5.2 mou-changes@lists.linx.net mailing list, which is intended to notify relevant and authorised personnel of any changes to this MoU in accordance with Clause 14 "Changes";
 - 4.5.3 membership@lists.linx.net mailing list, which is intended to carry announcements relating to the administration and corporate matters of LINX.

AND

THAT the referenced mail domain be changed from linx.net to lists.linx.net, in the MoU referenced document 'LAN Announcements Reference Document'.

THAT the LINX Fees Schedule and Services Definition be approved, as detailed in the document
