

Explanatory notes to Resolution [XX]

What does this amendment do?

It changes all references in the MoU to LINX operated mailing lists so that they refer to the subdomain @lists.linx.net instead of the main domain @linx.net.

It also makes the same changes throughout the MoU referenced document, 'LAN announcements reference document.

Why is LINX changing the subdomain for its mailing lists?

This change enables LINX to cleanly separate the mail server infrastructure for internal staff email from the mail server infrastructure used for member-facing mailing lists. Doing so will reduce e-mail systems complexity and remove a possible failure mode caused by compromises we are currently forced to make in the technical architecture.

Why can't you just forward mail from the existing addresses to the new system?

Please see the "Technical explanation of LINX e-mail Architecture", below.

Why is an MoU change necessary?

The MoU makes explicit reference to certain mailing lists, including some to which members are required to subscribe. This means we can't move mailing lists to the new subdomain without making the MoU change first.

What changes will members have to make themselves?

Member may need to update their mail handling filters, as mail to these mailing lists will now originate from the lists.linx.net subdomain.

To facilitate this there are two options to LINX as outlined below and we are seeing feedback on members' preference between these two options as well as the change itself.

Will this happen all at once, or will there be a managed transition?

In addition to asking for feedback on the change itself, we propose one of two options and would like feedback on these from the membership:

- 1. A parallel run for three months, where emails will be sent from the old xxxx@linx.net "legacy" domain as well as from the replacement <u>xxxx@list.linx.net</u> domain. In other words each subscriber to each mailing list would get two emails.
- A "flag day", a set day switch-over whereby we will cease to send on the xxxx@linx.net "legacy" domain and move instantly to the new, "replacement" xxxx@list.linx.net domain.

Note: Whilst we did look at the option to have a more graceful transition, the workload across the mail management application, mail servers, API development and portal would mean significant overhead for a temporary conversion period of at the most, three months. This would also carry some risk as there would be two authoritative lists at the same time.

In the case of option one above we will start using both mailing lists in early November 2021 and in the cast of option two we will announce the flag day before the Christmas freeze 2021 if the resolution pass at the November EGM.

Technical explanation of LINX e-mail architecture

For many years, LINX managed the mail for supporting staff internal e-mail and member-facing mailing lists through the same infrastructure, which was self-hosted SMTP and IMAP servers.

In recent years, LINX migrated internal e-mail to cloud-based servers, as part of a broader adoption of Microsoft Office 365 for many internal business applications.

To achieve this on a single mail domain we have had to employ a workaround: we continue to receive all mail, including internal mail, on the legacy systems and forward internal mail to Office365 for delivery.

It is not possible to direct all LINX e-mail straight to Office365 and forward the mailing lists to the legacy infrastructure. Forwarding mail for mailing lists to a different server would also break DKIM (the anti-spam protocol), which is specifically designed to ensure a match between the infrastructure used and the infrastructure you think you are using.

As a result, LINX is currently forced to direct all staff internal mail to the legacy infrastructure that handles mailing lists, and forward it from there to the actual mail server for staff mail, which is Microsoft Office365. If we could instead direct such mail straight to the Office365 mail server it would reduce complexity and increase resilience by removing a possible failure mode.

After this transition we will support DKIM on all our domains.

Changes to the MoU referenced document "LAN announcements reference document"

Below follows a copy of the LAN Announcements reference document, as it will stand after the resolution.

The only changes are to change the referenced mail domain from linx.net to lists.linx.net. This is highlighted in the text below each time it occurs.

Filtering

We recognise that these days, everyone needs to filter their mail - but please do not filter all mail from the **lists.linx.net** domain as if it is the same, this defeats the point of having separate mailing lists.

Each list has a distinct purpose, and a distinct 'List-Id' header, as described below. We have seen too many instances of members missing significant announcements, so please take this guidance point seriously.

Mandatory Lists

LINX members must maintain at least one subscription to each mandatory mailing list (it is an MoU requirement) and this is monitored automatically.

membership@lists.linx.net

(List-Id header = membership@lists.linx.net)

- This list is used for discussion amongst members on any topic, and for announcements from staff to members mainly (but not exclusively) on non-operational topics. All new members are announced on this list, for example.
- List traffic is not large.
- A closed list, no exploders permitted.
- Posting by list members only.
- Any attempts to post outside the permitted policy comes for moderation to the list owner (LINX CEO).

mou-changes@<mark>lists.</mark>linx.net (List-Id headers = mou-changes@<mark>lists.</mark>linx.net)

The **mou-changes@lists.linx.net** list is only used for formal announcements of changes to the LINX MoU resulting from member votes at general meetings. This is fairly rare (typically less than four times per annum).

- These are both closed lists, no exploders permitted.
- Posting by LINX staff only.

Ops-Announce Mailing Lists - for LINX staff announcements

You can choose to subscribe to the overall list (ops-announce@linx.net) and you will receive all posts for all of LINX's Peering LANs. Or as an alternative, subscribe only to the specific mailing list(s) covering the Peering LAN(s) that you are connected to.

- Freely redistributable but please use responsibly! (check first with LINX staff if you are unsure about this)
- Exploders/aliases are allowed
- Open subscription policy to LINX members and partners
- Closed list with real and "no-mail" (silent) subscribers only members of the LINX staff list may post




