GROUP STRATEGIC REPORT
FOR THE YEAR ENDED 31 DECEMBER 2018

INTRODUCTION

The company is a membership organisation whose principal activity is to provide Internet Exchange Points for the mutual benefit of members, to promote the interests of members and to represent members in matters of public interest.

BUSINESS REVIEW

The directors consider that the company has continued to perform well during this financial year. Connected capacity growth continued with a 19% increase to almost 26 Tb/s by the end of 2018. We maintained the position of showing a small financial surplus, and revenue grew despite cuts in services prices at the beginning of the year. Additionally, good performance results were consistently achieved across our measurement metrics.

The positive view of the future supported us making further significant reductions in our prices from the beginning of 2019.

During 2019 we will commence providing services to Saudi Telecom Company, under a management services contract, for the establishment and running of an internet exchange point based in Jeddah.

We were very pleased to report consistently high operational performance, with network availability statistics exceeding 99.99% over the whole year. This was achieved through the quality of our technical teams and such was reflected in good member satisfaction feedback statistics.

PRINCIPAL RISKS AND UNCERTAINTIES

Despite being in an increasingly competitive business sector, our membership continued to grow and our overall financial results for the year exceeded the underlying assumptions included in the budget presented to, and agreed by, our members.

Providing a good level of service is an important factor in retaining existing, and gaining new, revenue streams. Our network availability and resilience remained very high and our close relationship with our members enabled us to satisfy members demands with resulting positive feedback in our membership surveys.

We have managed to utilise our network equipment more effectively in coping with demands on the system, and this has enabled us to spend considerably less on capital expenditure than originally forecast. This has contributed to our ability to further reduce our prices in 2019.

The continuing demand for our largest capacity 100Gb ports represented a 37% increase in related connections over the year. This put us in a strong position as we entered the new financial year.

FINANCIAL KEY PERFORMANCE INDICATORS

We reduced the prices of our services on 1st January 2018 and this resulted in an immediate fall in revenues at the beginning of the year. Increased demand for services during the year saw this shortfall being recovered and by the end of 2018 our overall revenues exceeded the previous year (2018: £15.8m, 2017: £15.7m).

Close control over expenditure was maintained and our total expenditure for 2018 was less than budgeted by a large margin.

Our ability to reduce capital expenditure, together with lower operational expenditure, resulted in a small surplus being achieved, rather than a budgeted deficit, and our bank balances of £5m+ were consequential higher than expected. This status supported our ability to implement further price cuts at the beginning of 2019.

The directors consider that they have maintained an appropriate balance in our financial situation and our policy of reducing prices continues to be vindicated by the high rate of new membership applications (95 in 2018). This policy of continuing to reduce prices has been explicitly endorsed by a membership vote.

OTHER KEY PERFORMANCE INDICATORS

The traffic carried at LINX again grew during the year, and we finished the year with total peak traffic of around 4.34Tb/sec overall on the exchange (up around 8.5%).

LINX membership continues to grow at 5% per annum and the number of members was 821 at the end of 2018. The growth in membership assists all current members, since it provides new peering opportunities and supports the rationale for our principal activities.

LINX remains one of the largest and most important Internet Exchanges in the world, with exchange locations in England, Scotland, Wales and the USA. LINX continues to attract new members from Europe, the Middle East, Asia, Africa, the Americas and Australasia, having established itself as a key facility on a global scale. By the end of 2018, LINX was serving members from 82 countries which is a continuing increase from previous years. The London Internet Exchange is a group of four companies. London Internet Exchange Ltd, established in 1994, (LINX) and London Internet Exchange Trading Ltd, established in 2013, (LINX Trading) are the two UK companies in the group in respect of which audited accounts are filed at Companies House.

The group also comprises two overseas companies: LINX USA Inc and LINX America Inc. LINX USA was established in 2013 as the operational vehicle for LINX NoVA, our exchange in North Virginia, and LINX America was established in 2014 to support the promotion of LINX NoVA. The results of these companies are included in this consolidated report and accompanying financial statements.

This report therefore covers both LINX and the consolidation of the group as a whole.

The surplus for the year, after taxation, amounted to £137,266 (2017 - £133,056).

Opinion

We have audited the financial statements of London Internet Exchange Limited (the 'parent Company') and its subsidiaries (the 'Group') for the year ended 31 December 2018, which comprise the Group Statement of Income and Retained Earnings, the Group and Company Balance Sheets, the Group Statement of Cash Flows and the related notes, including a summary of significant accounting policies. 

NOTES TO THE FINANCIAL STATEMENTS

1. GENERAL INFORMATION

London Internet Exchange Limited is a private company limited by guarantee, incorporated in England and Wales. Its registered office is Trinity Court, Trinity Street, Peterborough, PE1 1DA.

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires Group management to exercise judgment in applying the Company's accounting policies (see note 3).

The following principal accounting policies have been applied.

2.2 BASIS OF CONSOLIDATION

The consolidated financial statements present the results of group and its own subsidiaries ("the group") as if they formed a single entity. Intercompany transactions and balances between group companies are therefore eliminated in full.

2.3 INCOME

Income is recognised to the extent that it is probable that the economic benefits will flow to the Group and the income can be reliably measured. Income is measured as the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes. The following criteria must also be met before income is recognised:

Income from a contract to provide services is recognised in the period in which the services are provided in accordance with the stage of completion of the contract when all of the following conditions are satisfied:

- the amount of income can be measured reliably;
- it is probable that the Group will receive the consideration due under the contract;
- the stage of completion of the contract at the end of the reporting period can be measured reliably, and;
- the costs incurred and the costs to complete the contract can be measured reliably.

2.4 TANGIBLE FIXED ASSETS

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

The Group adds to the carrying amount of an item of fixed assets the cost of replacing part of such an item when that cost is incurred, if the replacement part is expected to provide incremental future benefits to the Group. The carrying amount of the replaced part is derecognised. Repairs and maintenance are charged to the Statement of Income and Retained Earnings during the period in which they are incurred.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method. The estimated useful lives range as follows:

The estimated useful lives range as follows:

Leasehold property improvements - 5 years straight line
Network assets - 3-4 years straight line
Computer equipment - 2-4 years straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within 'other operating income' in the statement of comprehensive income.

2.5 OPERATING LEASES

Rentals paid under operating leases are charged to the Statement of Income and Retained Earnings on a straight line basis over the period of the lease.

2.6 VALUATION OF INVESTMENTS

Investments in subsidiaries are measured at cost less accumulated impairment.

2.7 FOREIGN CURRENCY TRANSLATION

Functional and presentational currency

The company's functional and presentational currency is GBP.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Foreign exchange gains and losses resulting from the settlement of transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the Statement of Income and Retained Earnings except when deferred in other comprehensive income as qualifying cash flow hedges.

Financial statements of overseas subsidiaries are translated at the rate ruling at the balance sheet date for the balance sheet items, and the average rate for the year for the items in the Statement of Income and Retained Earnings.

2.8 PENSIONS

Defined contribution pension plan

The Group operates a defined contribution plan for its employees. A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. Once the contributions have been paid the Group has no further payment obligations.

The contributions are recognised as an expense in the Statement of Income and Retained Earnings when they fall due. Amounts not paid are shown in accruals as a liability in the Balance Sheet. The assets of the plan are held separately from the Group in independently administered funds.

2.9 TAXATION

Tax is recognised in the Statement of Income and Retained Earnings, except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the Company and the Group operate and generate income.

2.10 DEBTORS

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

2.11 CASH AND CASH EQUIVALENTS

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

2.12 FINANCIAL INSTRUMENTS

The company only enters into basic financial instruments transactions that result in the recognition of financial assets and liabilities like trade and other accounts receivable and payable, loans from banks and other third parties, loans to related parties and investments in non-puttable ordinary shares.

Debt instruments that are payable or receivable within one year, typically trade payables or receivables, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration, expected to be paid or received.

Financial assets that are measured at cost and amortised cost are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the Statement of Income and Retained Earnings.

2.13 CREDITORS

Short term creditors are measured at the transaction price. Other financial liabilities are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

3. JUDGMENTS IN APPLYING ACCOUNTING POLICIES AND KEY SOURCES OF ESTIMATION UNCERTAINTY

Estimates and judgements are continually evaluated and are based on historic experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. Although these estimates are based on management's best knowledge of the amount, events or actions, actual results ultimately may differ from those estimates. The directors consider the depreciation of fixed assets to be a critical estimate and judgement applicable to the financial statements.
